In all other circumstances, the following licence terms and conditions shall apply:

- I. You are granted a non-exclusive, royalty free, revocable licence solely to view the licensed mapping and addressing data (including the link between the address and its location, and any underlying co-ordinates) provided via the Search for local land charges service as a source of information for
  - a) personal, non-commercial use;
  - b) use in the conveyancing process and for making property enquiries (for instance, to search for and view local charges registrations as part of a property transaction or prospective transaction, or for litigation or enforcement purposes or for property management);
- II. You are not permitted to copy, sub-license, distribute, sell or otherwise make available such data to third parties in any form, save for the making and provision of hard copy prints, pdf's or single screen shots of Search for local land charges service results, in each case for the purpose described in I. above; and
- III. You are not permitted to use the licensed mapping and addressing data (including the link between the address and its location, and any underlying co-ordinates) for the purpose of creating or developing any product or service intended for sub-licensing, distribution or sale to third parties (notwithstanding that the mapping or addressing data (including the link between the address and its location, and any underlying co-ordinates) themselves may not actually be supplied as part of such product or service).
